 - a. Take a photo during the Sharks Game. This could be a photo taken via the official Battlefield 1 photobooth at Shark Park.
 - b. Post the photo on your Instagram, Twitter and/or Facebook profile.
 - c. Ensure that your privacy settings for this photo are adjusted to public.
 - d. To be eligible, all competition entries must be accompanied with the hashtags #EAContest AND #OurBattlefield.

Guidelines and Restrictions:

- Content Requirements
 - Entries must (i) incorporate only the Sponsor-provided game images as instructed herein (the "Contest Assets") and/or the entrant's own originally created artwork ("Original Creations").  - Judging Phase: During the Judging Phase, a panel of qualified judges determined by Electronic Arts in its sole discretion will select the best Entry (the "Top Entry") based on the following criteria ("Judging Criteria"): 35% Creativity, 10% Humor, 30% Appropriateness to the Topic and 25% Originality.
 - b. In the event of a tie, the entrant whose Entry received the highest score for Creativity, as determined by the qualified judges, in their sole discretion, will be deemed a potential winner.
- 6. **Notification:** The potential winners will be notified by at half time during the National Rugby League match by an on field MC announcement at approximately 8:10PM AEST on 27 August 2016.
