1. To Enter

To enter the Shoutcaster Showdown Contest (the "Contest"), perform the following steps between 12:00:01 a.m. PST on December 3, 2018 through 11:59:59 p.m. PST on January 3, 2019 (the "Contest Period"):

- Choose and download one of the Sponsor provided video sequences from Madden NFL 19 (the "Contest Assets");
- Create and record a video of yourself or with a friend ("Entrant(s)") commentating on the gameplay from any one of the Contest Assets provided;
- Upload your video to your personal YouTube channel.
 - You will need a Google account to upload videos to Youtube. If you do not already have a Google account, you can visit <u>https://www.youtube.com/account</u> to create one for free.
 - If you are entering with a friend, only 1 Entrant needs to post the video to their personal YouTube account;
 - Videos must include the tag #EAcontest to be considered a valid entry in this Contest.
- Return to the Contest Site, fill in and submit all of the required registration fields in the entry form including the link to your YouTube video (collectively, the "Entry").
- If you are entering with a friend, both Entrants must:
 - Submit their own entry form on the Contest Site;
 - Provide their partner's email address in the "COMMENTATOR #2 EMAIL ADDRESS" field;
 - Provide the same YouTube link in the entry form; and
 - Meet all eligibility criteria provided in Section 4 of these Official Rules.

2. Limit

You may submit multiple Entries and pair with multiple Entrants, but are only eligible to win one prize. For purposes of this Contest all Entries will be presumed authored by the person submitting the Entry.

3. Entry Requirements and Restrictions

By entering, Entrants warrant that their Entries contain only Sponsor-provided Contest Assets, if any, and/or their own, original creations. Entrants further warrant their Entries do not contain any third party copyrighted materials, and otherwise do not violate or infringe the rights, including, without limitation, copyrights, trademark rights or rights of publicity/privacy, of any third party. Sponsor grants Entrants a limited, non-exclusive, non-commercial license to use the Contest Assets solely in connection with, and as a part of, the Contest. Entrants shall otherwise have no right, title or interest in or to any Contest Assets, and any use of the Contest Assets (including use of the Entry that contains Contest Assets) other than as permitted by these Official Rules may constitute copyright and/or trademark infringement. Entries may only incorporate the likeness and names of the submitting Entrant(s) as described in Section 1 of these Official Rules. Entries must not have been submitted in other contests or been previously published. Entries must be suitable for publication and appropriate for a general audience. Entries must not contain any racial, religious or ethnic slurs, explicit language, obscene, pornographic, violent, or sexual content, libel, hate speech, reference to alcohol, drugs or other illicit substances or otherwise unlawful, inappropriate, objectionable, offensive or illicit content, as determined by Sponsor in its sole discretion. Sponsor, in its sole discretion, reserves the right to disqualify any Entry that does not follow these requirements and/or incorporates prohibited content. Disqualified entries will not be eligible to win any prize.

Completed entries must be sent electronically during the Contest Period and received by 11:59:59 p.m. PST on January 3, 2019. All entries become the property of Sponsor and will not be returned. Sponsor assumes no responsibility for lost, incomplete, incorrect, or misdirected entries. Proof of submission of Contest Entry is not considered proof of delivery or receipt of such Entry by Sponsor. Sponsor and its Agents (defined below) assume no responsibility for lost, late, intercepted, incomplete, incorrect, or misdirected entries, or Entries not otherwise received by Sponsor. Use of a false email account will disqualify an Entry. Sponsor and its Agents (defined below) are not responsible for technical, hardware or software malfunctions, misdirected entries, lost or unavailable network connections, or failed, incorrect, inaccurate, incomplete, lost, late, illegible, misdirected, garbled, damaged or delayed electronic or other communications or other technical problems related to emailed Entries. By entering, Entrants accept and agree to abide by the terms of these Official Rules.

4. Eligibility

This Contest is only open to residents of the 50 United States and Canada (except Quebec)" who are 18 years of age or older at time of entry and who had Internet access as of November 26, 2018. This Contest is void in Quebec. Employees of EA, its affiliates, subsidiaries, representatives, advertising, promotion and publicity agencies ("Sponsor and its Agents") and the immediate family members and persons living in the same household of each are not

eligible. Contest is void where prohibited, restricted or taxed by law. All federal, state, provincial, and local laws and regulations apply.

5. Entry Judging

On or about [1-3 DAYS AFTER END DATE], Sponsor or its designee (the "Contest Judge"), whose decisions are final and binding on all matters relating to the Contest, will independently evaluate and judge all eligible Entries received and select in its sole and absolute discretion, will select the top four (4) from all eligible Entries based on the following criteria:

- 33% Showcase of Knowledge of Madden NFL 19
- 34% Creativity
- 33% On-Camera Presentation.

In the unlikely event of any ties, the winner(s) among the tying Entry(ies) will be that with the highest ranking in the Creativity category. The Contest Judge's decisions are final and binding.

6. Winner Selection and Notification

On or about January 10th, the potential winners will be determined and notified by an email sent to the email address specified on the Contest Entry. If any potential winner cannot be contacted at this email address, is contacted and does not respond as directed within 3 days of attempted notification, fails to sign and/or return the Winner Declaration & Consent within the required time period, refuses the prize, is ineligible to accept the prize, or the prize is returned as undeliverable, all potential winners associated with the Entry forfeit the prize. If a winner is 18 or older, as required, but a minor in his or her state, country or province of residence, winner's parent or legal guardian will be required to sign all necessary documents. hotel and the EA studio.
