## 2017 Official Rules

1. Entry. No other methods of entry will be accepted. Limit: only one entry per person, email address and/or household will be accepted. All electronic entries must be received by 11:59:59 p.m. PST on **November 14, 2017**. Mail-in entries must be postmarked during Sweepstakes Period and received by November 21, 2017. Entries become the property of Sponsor and will not be returned. Use of a false email account or an incorrect mail address will disqualify an entry. Sponsor is not responsible for technical, hardware or software malfunctions, lost or unavailable network connections, or failed, incorrect, inaccurate, incomplete, lost, late, misdirected, illegible, mutilated, postage-due, garbled or delayed entries or other communications or other technical problems related to website entries. Sponsor, in its sole discretion, reserves the right to disqualify any person who tampers with the entry process or the operation of the Site, or who otherwise violates these rules. By entering, entrants accept and agree to abide by the terms of these Official Rules.

- 2. Eligibility. This Sweepstakes is only open to residents of Canada (except Quebec) who are 13 years of age or older at time Sweepstakes begins and who had Internet access as of October 10, 2017. Residents of Quebec are not eligible. Employees of EA, and its respective affiliates, subsidiaries, representatives, advertising, promotion and publicity agencies ("Sponsor and its Agents") and those of the National Hockey League (the "NHL"), Oilers Entertainment Group Canada Corp., Edmonton Oilers Hockey Corp., NHL Enterprises, L.P., NHL Enterprises Canada, L.P., NHL Enterprises B.V., and NHL Interactive CyberEnterprises, LLC (the foregoing NHL entities collectively, the "NHL Entities") and the immediate family members and persons living in the same household of each are not eligible. Sweepstakes is void where prohibited, restricted or taxed by law. All federal, state and local laws and regulations apply.
- **3. Prizes; Winner Selection and Notification.** There is one (1) prize. Odds of winning any prize depend upon the number of eligible Entries in the Sweepstakes.

One (1) Grand Prize: One (1) Winner will receive a prize trip to Las Vegas, Nevada to attend the January 13, 2018 Edmonton Oilers vs Vegas Golden Knight hockey game, a custom Edmonton

Oilers-branded PlayStation 4, one Edmonton Oilers team jersey, one (1) copy of each of the following videogames for PlayStation 4: NHL 18, FIFA 18, Madden NFL 18, and NBA LIVE 18. Winner must be able to travel to the January 13, 2018 game.

Prize trip is for two (2) persons (Winner and a Guest) to Las Vegas, Nevada. Trip includes roundtrip, economy/coach class airfare for 2 people (Winner and Guest) from the major commercial airport nearest the Winner's residence (Winner and Guest must travel together on same itinerary); hotel accommodations for 3 days / 2 nights (one (1) double occupancy room) at the hotel of Sponsor's choice; 2 tickets to the January 13, 2018 Edmonton Oilers @ Vegas Golden Knights game (location of seats to be determined by Sponsor in its sole discretion). Incidentals, including, without limitation: telephone calls, facsimile charges, Internet charges, Spa/beauty salon services, laundry, tours/excursions, gift shop purchases, hotel processing fees and airline service charges, are the sole responsibility of the Winner and his or her Guest. Hotel and airfare cannot be used separately. Winner must notify Sponsor of intended dates of travel by no later than 1 month prior to the intended date of departure. All travel must be completed by January 13, 2018 or prize will be forfeited in its entirety. Travel and accommodations are subject to availability and certain restrictions, so Sponsor cannot guarantee prize trip will be available on the exact dates specified by Winner. The drawing will be conducted at Sponsor's address as indicated at the beginning of these rules by Sponsor or its designee, the judge of the Sweepstakes, whose decisions are final and binding.
