

## Washington Capitals EA SPORTS™ Sweepstakes

### 2018 Official Rules

**NO PURCHASE NECESSARY. A PURCHASE DOES NOT INCREASE YOUR CHANCE OF WINNING. VOID IN QUEBEC AND WHERE PROHIBITED.**

**1. Entry.** To enter the Washington Capitals EA SPORTS Sweepstakes (the "Sweepstakes"), submit your first name, last name, email address, birthdate, country of residence and opt in for marketing emails from EA (collectively, the "Entry" or "Entries") on the <https://www.easports.com/nhl/teams/washington-capitals> website as directed between October 17, 2018 at 12:01 am Pacific Standard Time ("PST") and November 14, 2018 at 11:59:59 pm PST (the "Sweepstakes Period"). No other methods of entry will be accepted. Limit: only one entry per person, email address and/or household will be accepted. All electronic entries must be received by 11:59:59 p.m. PST on November 14, 2018. Mail-in entries must be postmarked during Sweepstakes Period and received by November 21, 2018. Entries become the property of Sponsor and will not be returned. Use of a false email account or an incorrect mail address will disqualify an entry. Sponsor is not responsible for technical, hardware or software malfunctions, lost or unavailable network connections, or failed, incorrect, inaccurate, incomplete, lost, late, misdirected, illegible, mutilated, postage-due, garbled or delayed entries or other communications or other technical problems related to website entries. Sponsor, in its sole discretion, reserves the right to disqualify any person who tampers with the entry process or the operation of the Site, or who otherwise violates these rules. By entering, entrants accept and agree to abide by the terms of these Official Rules.

**2. Eligibility.** This Sweepstakes is only open to residents of the 50 United States and the District of Columbia and Canada (except Quebec) who are 13 years of age or older at time Sweepstakes begins and who had Internet access as of October 10, 2018. Residents of Quebec are not eligible. Employees of EA and its respective affiliates, subsidiaries,

representatives, advertising, promotion and publicity agencies (“Sponsor and its Agents”) and those of the National Hockey League (the “NHL”), Washington Capitals, NHL Enterprises, L.P., NHL Enterprises Canada, L.P., NHL Enterprises B.V., and NHL Interactive CyberEnterprises, LLC (the foregoing NHL entities collectively, the “NHL Entities”) and the immediate family members and persons living in the same household of each are not eligible. Sweepstakes is void where prohibited, restricted or taxed by law. All federal, state and local laws and regulations apply.

**3. Prizes; Winner Selection and Notification.** There is one (1) prize. Odds of winning any prize depend upon the number of eligible Entries in the Sweepstakes.

Grand Prize: One (1) Winner will receive a Custom Washington Capitals branded Xbox One console; one (1) signed Washington Capitals jersey; four (4) tickets to a Washington Capitals game of the Washington Capitals’ choice; and one (1) copy of each of the following videogames for Xbox One: NHL 19, FIFA 19, Madden NFL 19, and NBA LIVE 19.

Neither travel nor accommodations are included. Approximate retail value (“ARV”) is US\$1800.

Prizes are not transferable. No substitution of prizes for cash or other goods and services is permitted, except Sponsor reserves the right to provide a substitute prize of approximately equal value. Game versions, including platform for play, consoles make/model, and Jersey sizes to be awarded as prizes are within the sole discretion of Sponsor and subject to availability.

Platforms/consoles are not included in prizes except as otherwise stated in these Official Rules. All expenses not specified above, including, without limitation, all federal, state and local taxes, and international tariffs, are the sole responsibility of the individual winners.

Potential winners will be determined by random drawing on or about November 24, 2018 from all eligible Entries received. The drawing will be conducted at Sponsor’s address as indicated at the beginning of these rules by Sponsor or its designee, the judge of the Sweepstakes, whose decisions are final and binding.

Potential winners may be required to complete and sign a Winner Declaration & Release, in the form provided by Sponsor, within 14 days of attempted notification in order to claim prize. If a minor wins a prize, it will be awarded in the name of the minor’s parent or legal guardian, who will also be responsible for signing any necessary releases, consents and affidavits. Canadian winners must also answer a skill-based question in order to claim prize. Potential winners will be notified on or about November 24, 2018 by an email sent to the email address specified on the Entry or by a mailed notification if no email is provided on a mail-in entry. If a potential winner cannot be contacted at this email address, is contacted and does not respond as directed within 14 days of attempted notification, fails to sign and/or return the Winner Declaration & Release, refuses the prize, is ineligible to accept the prize, or prize is returned as undeliverable, the potential winner forfeits the prize. If a winner is 18 or older, as required, but a minor in his or her state, country or providence of residence, winner’s parent or legal guardian will be required to sign all necessary documents. Receiving a prize is contingent upon compliance with these Official Rules; all prizes claimed in accordance with these Official Rules will be awarded. In the event that a potential winner is disqualified or the prize is forfeited for any reason, Sponsor will award the applicable prize, time permitting given the nature of the prize, to an alternate winner by random drawing from all remaining eligible Entries. Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, if any fraud, technical failures, computer virus, bug, tampering, or any other factor impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion. Sponsor has the right to select winners from eligible Entries at any time before the termination of the Sweepstakes. If terminated Sponsor may, in its sole discretion, determine the winners from among all non-suspect, eligible Entries received up to time of such action. By participating in this Sweepstakes, Entrants agree to be bound by these Official Rules and the decisions of the judges and to be contacted by Sponsor or its agents by telephone, mail and/or email regarding this Sweepstakes. If there is a dispute regarding the identity of an Entrant, the Entry will be deemed submitted by the person in whose name the email account is registered. The Sweepstakes is governed by the laws of the United States and all claims must be resolved in the United States.
